- 1. Set date for annual meeting and discuss (Judy will be gone October 16-23)

- 2. Bids for tree removal Hank Hank received 3 bids for the removal of the dead tree in our common area, 2 were written and 1 was over the phone. There was quite a large difference in cost between them so the Board decided on the least expensive making sure everything was covered to include cutting the tree down, removal, and grinding out the stump. The area where the tree was will be replaced with mulch and we will have our landscapers take care of that.
- 3. AT&T update

AT&T set up a tent at the entrance of our community (not on our property) to inform residents about the new fiberoptic lines that have been installed in our community. Since we are partners with Comcast, they were not allowed inside our property lines. They had a good turnout but we had complaints about the amount of traffic and congestion it caused at our entrance, so when they requested more dates for meetings, they were denied. All residents received a notice in the mail letting everyone know that the deadline for signing up for the new service is October 1.

4. Comcast offers via Broadband

Comcast has generously offered to pay for social events such as the Ice Cream truck that we have during the summer months and Carol was working on other benefits with them. One thing that we were told is repairing utility boxes in the neighborhood, no matter what company they belong to which is great. Carol will be taking pictures and letting them know which ones need repair.
